# Explanatory notes on venue and resolutions to be proposed

### Venue

The Annual General meeting will be held at 6:30 pm on Monday 19 March 2012 at the Centre for Classical And Near Eastern Studies of Australia ("CCANESA"), Madsen Building, Eastern Avenue, The University of Sydney. The Madsen Building is the first building on the left as you enter Eastern Avenue from City Road, and CCANESA is is on the first floor above the entrance level. When entering the building, take the first staircase straight in front of you and this will lead you directly to CCANESA. There are also lifts at the rear of the building.

### **Election of President**

At the invitation of the Council, Dr Robert Harper SC has kindly agreed to stand for election as President of the Association. After a distinguished career at Sydney Grammar School, at which he won the prize for Classical Greek, and at The University of Sydney, culminating in the award of the degree of Doctor of Philosophy in 1997, Robert has pursued an outstanding career in the law and was appointed Senior Counsel for New South Wales in 2004. Throughout his legal career, Robert has retained his interest in the Classics. Since 2003 he has been Chairman of the Kudos Foundation, a charity supporting the study of Classical Languages in Australia, and he is also a member of the Executive Committee of the Australian Archaeological Institute at Athens.
